Applicants for a contract can present competitive proposals according to the following options, or a combination of any of the following options:

- a. Competitive proposal for Cuyahoga County (excluding Benjamin Rose sites), only (Group A), Appendix A;
- b. Competitive proposal for Lake County, only (Group B), Appendix B;
- c. Competitive proposal for Medina County, only (Group C), Appendix C;
- d. Competitive proposal for Lorain County, only (Group D), Appendix D;
- e. Competitive proposal for Kosher meals, only (Group E), Appendix E;
- f. Competitive proposal for Asian meals, only (Group F), Appendix F;
- g. Competitive proposal for Hispanic Meals, only (Group G), Appendix G;
- h. Competitive proposal for Benjamin Rose sites in Cuyahoga County, only (Group H), Appendix H; and,
- i. Competitive proposal for Geauga County, only, if Geauga County participates in this Program (Group I), Appendix I.

*Excerpt from Request for Proposals, page 7:*

One (1) Competitive Proposal packet with original signatures, plus one copy of the packet, must be received by the Western Reserve Area Agency on Aging (WRAAA) at 1700 East 13th Street, Cleveland, Ohio, 44114 by 4:00 p.m. on September 23, 2019. Faxed or emailed proposals will be rejected. It is the responsibility of an Applicant to obtain from WRAAA a receipt to verify delivery of the Applicant's packet.

Each competitive proposal in excess of \$10,000.00 must be accompanied by a Proposal Bond [a.k.a. "Bid Bond"] executed by a surety company authorized to do business in the State of Ohio, a "Certified Check," "Cashier's Check" or "Money Order" drawn on a solvent bank or savings and loan association, payable to the Western Reserve Area Agency on Aging in a sum equal to five percent (5%) of the amount proposed in the competitive proposal, conditioned that if such proposal is accepted, the Food Preparer shall execute a contract in conformity with this request for competitive proposals and all contract specifications.
