- **Answer:** If you are referring to the unit cost, this amount is determined by the amount of units you propose to serve (line A4) and the amount of OAA funds that you propose (line B1). These proposed numbers are determined by you, the applicant. The only service with a fixed rate is Nutrition Education.
- Question: Is Personal Emergency Response Service (PERS) or medication management covered in this RFP?
